TRANSFER OF FUNDS – POLICE DEPARTMENT

HIS HONOR, MAYOR SULLIVAN HAS SUBMITTED TO THE BRAINTREE TOWN COUNCIL A REQUEST FOR TRANSFER OF FUNDS FOR THE POLICE DEPARTMENT.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRAINTREE THAT THE FOLLOWING SUMS BE TRANSFERRED TO SUPPLEMENT FUNDS PREVIOUSLY APPROPRIATED FOR THE FISCAL YEAR 2009 POLICE DEPARTMENT BUDGET, SAID AMOUNTS TO BE EXPENDED UNDER THE DIRECTION OF THE POLICE CHIEF:

- A. THE SUM OF \$17,000 BE TRANSFERRED FROM POLICE DEPARTMENT/PROGRAM 04-PATROL BUREAU/SWORN PERSONNEL ACCOUNT TO POLICE DEPARTMENT/PROGRAM 05 – COMMUNICATIONS/OVERTIME ACCOUNT;
- B. THE SUM OF \$28,000 BE TRANSFERRED FROM POLICE DEPARTMENT/PROGRAM 04-PATROL BUREAU/SWORN PERSONNEL ACCOUNT TO POLICE DEPARTMENT/PROGRAM 08 – SPECIAL SERVICES/COMMUNITY POLICING/OVERTIME ACCOUNT;
- C. THE SUM OF \$15,000 BE TRANSFERRED FROM POLICE DEPARTMENT/PROGRAM 04-PATROL BUREAU/SWORN PERSONNEL ACCOUNT TO POLICE DEPARTMENT/PROGRAM 02 – BUILDING MAINTENANCE/FUEL OIL ACCOUNT;
- D. THE SUM OF \$13,000 BE TRANSFERRED FROM POLICE DEPARTMENT/PROGRAM 04-PATROL BUREAU/SWORN PERSONNEL ACCOUNT AND THE SUM OF \$2,000 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 04 – PATROL BUREAU/SHIFT DIFFERENTIAL ACCOUNT FOR A TOTAL OF \$15,000 TO BE TRANSFERRED TO THE POLICE DEPARTMENT/PROGRAM 02 – BUILDING MAINTENANCE/LIGHTING ACCOUNT;
- E. THE SUM OF \$2,125 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 04 – PATROL BUREAU/SHIFT DIFFERENTIAL ACCOUNT, THE SUM OF \$687 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 04 – PATROL BUREAU/CAREER INCENTIVE ACCOUNT, THE SUM OF \$13,751 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 04 – PATROL BUREAU/EDUCATIONAL ACCOUNT, AND THE SUM OF \$3,437 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 04 – PATROL BUREAU/HOLIDAY ACCOUNT FOR A TOTAL OF \$20,000 TO BE TRANSFERRED TO THE POLICE DEPARTMENT/PROGRAM 03 – EQUIPMENT MAINTENANCE/OUTSIDE MOTOR VEHICLE REPAIRS ACCOUNT;


- F. THAT THE SUM OF \$1,214 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 04 – PATROL BUREAU/HOLIDAY ACCOUNT, THE SUM OF \$1,800 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 04 – PATROL BUREAU/DEFIBRILLATOR TRAINING ACCOUNT, THE SUM OF \$1,440 BE TRANSFERRED FROM THE POLICE DEPARTMENT/ PROGRAM 06 – DETECTIVE BUREAU/SHIFT DIFFERENTIAL ACCOUNT, AND THE SUM OF \$546 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 06 – DETECTIVE BUREAU/DEFIBRILLATOR TRAINING ACCOUNT FOR A TOTAL OF \$5,000 TO BE TRANSFERRED TO THE POLICE DEPARTMENT/PROGRAM 03 – EQUIPMENT MAINTENANCE/TIRES/TUBES ACCOUNT;
- G. THAT THE SUM OF \$4,583 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 06 – DETECTIVE BUREAU/EDUCATIONAL ACCOUNT AND THE SUM OF \$417 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 06 – DETECTIVE BUREAU/HOLIDAY ACCOUNT FOR A TOTAL OF \$5,000 TO BE TRANSFERRED TO THE POLICE DEPARTMENT/PROGRAM 03 – EQUIPMENT MAINTENANCE/MOTOR VEHICLE PARTS AND ACCESSORIES ACCOUNT; AND
- H. THAT THE SUM OF \$1,133 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 06 – DETECTIVE BUREAU/HOLIDAY ACCOUNT, THE SUM OF \$2,250 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 04 – PATROL BUREAU/UNIFORM ALLOWANCES ACCOUNT, THE SUM OF \$1,275 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 04 – PATROL BUREAU/UNIFORM CLEANING ACCOUNT, THE SUM OF \$3,500 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 04 – PATROL BUREAU/PSYCHOLOGICAL TESTING ACCOUNT, THE SUM OF \$3,458 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 04 – PATROL BUREAU/EQUIPMENT – NEW HIRES ACCOUNT, THE SUM OF \$12,000 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 04- PATROL BUREAU/IN SERVICE TRAINING ACCOUNT, AND THE SUM OF \$750 BE TRANSFERRED FROM THE POLICE DEPARTMENT/PROGRAM 06 – DETECTIVES BUREAU/UNIFORM ALLOWANCE ACCOUNT, FOR A TOTAL OF \$24,366 TO BE TRANSFERRED TO THE POLICE DEPARTMENT/PROGRAM 03 – EQUIPMENT MAINTENANCE/GASOLINE ACCOUNT.
