TRANSFER OF FUNDS – DEPARTMENT OF PUBLIC WORKS HIGHWAY DIVISION

HIS HONOR, MAYOR SULLVAN HAS SUBMITTED THE BRAINTREE TOWN COUNCIL A REQUEST FOR TRANSFER OF FUNDS FOR THE DEPARTMENT OF PUBLIC WORKS HIGHWAY DIVISION.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRAINTREE THAT THE FOLLOWING SUMS BE TRANSFERRED TO SUPPLEMENT FUNDS PREVIOUSLY APPROPRIATED FOR THE FISCAL YEAR 2009 DEPARTMENT OF PUBLIC WORKS HIGHWAY DIVISION BUDGET:

- A. THAT THE SUM OF \$25,000 BE TRANSFERRED FROM THE TOWN COUNCIL/PROGRAM 01 – ADMINISTRATION/ADVERTISING ACCOUNT,
- B. THE SUM OF \$20,000 BE TRANSFERRED FROM THE FIRE DEPARTMENT/PROGRAM 04 – FIRE SUPPRESSION/UNIFORM BRANCH ACCOUNT,
- C. THE SUM OF \$5,000 BE TRANSFERRED FROM THE FIRE DEPARTMENT/PROGRAM 08 – TRAINING/IN-SERVICE TRAINING ACCOUNT.
- D. THE SUM OF \$1,650 BE TRANSFERRED FROM THE FIRE DEPARTMENT/PROGRAM 04 – FIRE SUPPRESSION/EMT INCENTIVE ACCOUNT,
- E. THE SUM OF \$1,673 BE TRANSFERRED FROM THE FIRE DEPARTMENT/PROGRAM 01 – ADMINISTRATION.DEPARTMENT HEAD ACCOUNT,
- F. THE SUM OF \$1,000 BE TRANSFERRED FROM THE FIRE DEPARTMENT/PROGRAM 01 – ADMINISTRATION/PRINTING/FORMS ACCOUNT,
- G. AND THE SUM OF \$677 BE TRANSFERRED FROM THE FIRE DEPARTMENT/PROGRAM 01 – ADMINISTRATION/PHOTO COPY RENTAL ACCOUNT,
- H. AND FOR THESE PURPOSES, THAT THE FOLLOWING SUMS BE TRANSFERRED:
 - I. \$15,000 TO THE DEPARTMENT OF PUBLIC WORKS/PROGRAM 06 – HIGHWAY/OVERTIME ACCOUNT AND

II. \$40,000 TO THE DEPARTMENT OF PUBLIC WORKS/PROGRAM 03 – EQUIPMENT MAINTENANCE/OUTSIDE MOTOR VEHICLE ACCOUNT.


