The Town Clerk explained that he had secured the services of the recently retired Assistant Town Clerk to assist in the Town Clerk Department during the upcoming November 3rd election. He expected a new Assistant Town Clerk would be hired by next month.

096-09 Councilor Kokoros: Town Clerk Starting Grade Level

Councilor Kokoros wanted clarification on the starting grade for the Town Clerk position. He stated the position was posted at a range and wanted to find out from members at what grade the position should start at.

Council President Dingee stated that the position started at a Grade Level A - the same level other positions hired by the Council began at.

Councilor Clifford stated that Council President was out of order to make that decision by himself. The Council should vote on that decision. Council President Dingee recommended that he should put a motion in writing and submit as Council Rules require and then it can be be sent to Committee for a recommendation. Councilor Clifford made a motion for Rule Twenty-Three "Suspension of Rules" to enable the Council to establish a starting grade level for the Town Clerk position.

Councilor Ryan made a motion that the Council endorse the starting grade level for the Town Clerk position to be M18-A

Discussion: Town Clerk, Joseph Powers, requested to speak before the Council to make an

argument to establish the position at the level he was making back in 2003. He explained when he was the elected Town Clerk in 2000 the position was at the "A" level and then increased to the "E" level in 2002 and 2003. He explained when he submitted his resume he noted that the salary fit between the range he was looking for but was negotiable.

Councilor Randolph commented that he believed the position was to start at the "A" level and especially with the current financial crisis, he would only support starting the position at the "A" level.

Town Clerk Powers remarked that at no point in time was the position advertised starting at the "A" level. Council President Dingee remarked that on the night Mr. Powers was appointed he spoke with him and stated that the position was to start at level "A" and the council had voted previously not to give step increses this year.

Councilor Clifford commented that the position was posted with a range and it would be fitting to do something better than the "A" level. Councilor Clifford then made a motion to to start the position at the Step "B" level. The motion was seconded by Councilor DeNapoli.

Council President Dingee remarked that a motion is already before them to recommend starting the position at step "A".

Councilor DeNapoli asked if the Clerk of the Council received a raise this year. Council President Dingee respondend "No".
