#### COMMUNICATION AND REPORTS FOR THE MAYOR AND TOWN BOARDS

As required under Section 6-3 of the Braintree Charter the Mayor shall submit to the Town Council a proposed operating budget for the ensuing fiscal year with an accompanying budget message and supporting documents not later than 60 days before the start of the town's fiscal year.

Mayor Sullivan informed members of the Council that the FY2013 Budget Proposal is at \$101 million, an increase of \$5 million over the previous year. About half of the \$5 million dollar increase (\$2,570,000) has been allocated to the schools. In addition to schools, Mayor Sullivan noted his commitment on public safety, recreation and seniors.

New Growth revenue is estimated to increase by \$50,000 to \$900,000 driven by \$4.8 million of new growth attributable to opening of the Hyatt Hotel, TD Bank and Dave & Buster's.

Mayor Sullivan noted that health care premiums will increase by 4%. He also noted that an adjustment to water/sewer rates will take place resulting in an average increase of under \$100. The last rate adjustment was in 2007. Mayor Sullivan updated members on the proposed new water plant. As of today, no decision has been made on a regional facility.
