REQUEST OF: NATIONAL GRID

National Grid hereby respectfully requests your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and of the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 570 feet, more or less, of 2 inch gas main in Louise Road, Braintree from the existing 2 inch gas main at house #11, northerly to the end of the main at house #50. Approval is conditioned on completion of the gas main installation by late summer to avoid coordination problems with the Town's water main installation contractor and under the normal conditions, with emphasis on the requirements that the gas main be laid outside of the trench of the water mains in service and that the trench pavement not be left low for any length of time.



PETITION OF NATIONAL GRID FOR GAS MAIN LOCATIONS




Town of Braintree / Town Council:
