TRANSFER OF FUNDS – GOLF COURSE

HIS HONOR, MAYOR SULLVAN HAS SUBMITTED THE BRAINTREE TOWN COUNCIL A REQUEST FOR TRANSFER OF FUNDS FOR THE GOLF COURSE.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRAINTREE THAT THE FOLLOWING SUMS BE TRANSFERRED TO SUPPLEMENT FUNDS PREVIOUSLY APPROPRIATED FOR THE FISCAL YEAR 2009 GOLF COURSE BUDGET:

- A. THAT THE SUM OF \$25, 793 BE TRANSFERRED FROM THE GOLF COURSE/PROGRAM 04 - TURF MAINTENANCE/CAPITAL IMPROVEMENTS ACCOUNT AND DISBURSED TO THE FOLLOWING PROGRAMS AND ACCOUNTS IN THE FOLLOWING AMOUNTS:
- B. \$8,500 TO THE GOLF COURSE/PROGRAM 02 – BUILDING MAINTENANCE/LIGHTING ACCOUNT,
- C. \$3,500 TO THE GOLF COURSE/PROGRAM 03 – EQUIPMENT MAINTENANCE/GASOLINE ACCOUNT,
- D. \$2,372 TO THE GOLF COURSE/PROGRAM 03 – EQUIPMENT MAINTENANCE/DIESEL ACCOUNT,
- E. \$5,883 TO THE GOLF COURSE/PROGRAM 03 – EQUIPMENT MAINTENANCE/MOWER REPAIRS ACCOUNT,
- F. \$1,313 TO THE GOLF COURSE/PROGRAM 05 – GOLF PRO ACCOUNT,
- G. \$1,000 TO THE GOLF COURSE/ PROGRAM 05 - /GOLF PRO/PRO STAFF REIMBURSEMENT ACCOUNT, AND
- H. \$3,225 TO THE GOLF COURSE/ PROGRAM 52 – LEASES/GOLF LEASES ACCOUNT.


