PETITION OF NATIONAL GRID FOR GAS MAIN LOCATIONS

The National Grid hereby respectfully request your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 920 feet, more or less of 2 inch gas main in Cedarcliff Road, Braintree.

From the existing 3 inch gas main at Shaw Street and Cedarcliff Road Northeasterly to the existing 2 inch gas main at Atlas Road of which to replace and abandon the existing 2 inch gas main in Cedarcliff Road, Braintree.


Petition #09-028 was unanimously approved by Council with the following conditions:

Petition #09- 028 Existing 15kv duct bank located on North side of Shaw St. opposite Cedarcliff Rd. to be marked out through Dig Safe.

09-028 – **Cedarcliff Road** has been reconstructed last year, but only to the binder course to provide for a stable roadway in which to eventually install a new water main. Late last year the main broke and will be replaced this year, so this petition **should be approved with our “standard” repair specifications** plus a reminder that the Town will have a water contractor on the street, so Nationalgrid will have to coordinate their work with our contractor to avoid interference or delays.
