PETITION OF NATIONAL GRID FOR GAS MAIN LOCATIONS

The National Grid hereby respectfully request your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 965 feet, more or less of 2 inch gas main in Cochato Road, Braintree.

From the existing 2 inch gas main in Cochato Road @ Storrs Avenue Southerly to the existing 2 inch gas main at Dean Street and to the existing 2 inch gas main at No. 17 Cochato Road. All of which to replace and abandon the existing 2 inch gas main in Cochato Road, Braintree.


Petition #09-035 was unanimously approved by Council with the following conditions:

Petition #09- 035 Storrs Ave. has **(2) 115kv** oil filled lines and a 15kv duct bank in close proximity to the proposed gas connection. The contractor shall notify BELD 48 hours prior to start of excavation.

09-035 –**Cochato Road** is in fairly decent condition and is not scheduled for roadway work, except its intersection with Storrs Avenue, which is to be reconstructed this year. To ensure that the gas main will be in before Town roadway work begins this petition **should be approved with our "standard" repair specifications.**



ORDER FOR GAS MAIN LOCATION


Town of Braintree / Board of Selectmen:
