HIS HONOR, MAYOR SULLVAN HAS SUBMITTED THE BRAINTREE TOWN COUNCIL A REQUEST FOR TRANSFER OF FUNDS FOR THE FOLLOWING DEPARTMENTS: FIRE, POLICE AND TOWN CLERK.

- I. BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRAINTREE THAT THE FOLLOWING SUMS BE TRANSFERRED TO SUPPLEMENT FUNDS PREVIOUSLY APPROPRIATED FOR THE FISCAL YEAR 2009 FIRE DEPARTMENT BUDGET:
 - A. THAT THE SUM OF \$6,650 BE TRANSFERRED FROM THE FIRE DEPARTMENT/PROGRAM 02 – BUILDING/NATURAL GAS ACCOUNT;
 - B. AND FOR THIS PURPOSE, THAT THE SUM OF \$2,450 TO THE FIRE DEPARTMENT/PROGRAM 01/ADMINISTRATION/TELEPHONE ACCOUNT AND THE SUM OF \$4,200 TO BE TRANSFERRED TO THE FIRE DEPARTMENT/PROGRAM 04 – FIRE SUPPRESSION/REPLACE FIRE EQUIPMENT ACCOUNT:

- II. BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRAINTREE THAT THE FOLLOWING SUMS BE TRANSFERRED TO SUPPLEMENT FUNDS PREVIOUSLY APPROPRIATED FOR THE FISCAL YEAR 2010 TOWN CLERK DEPARTMENT AND POLICE DEPARTMENT BUDGETS:


- A. THAT THE SUM OF \$15,000 BE TRANSFERRED FROM THE TOWN CLERK/PROGRAM 01 – ADMINISTRATION/ELECTED OFFICIALS ACCOUNT, THE SUM OF \$8,000 BE TRANSFERRED FROM THE TOWN CLERK/PROGRAM 05-REGISTRATION/ASSISTANT DEPARTMENT HEAD ACCOUNT, AND THE SUM OF \$7,000 BE TRANSFERRED FROM THE TOWN CLERK/PROGRAM 05-REGISTRATION/ADMINISTRATIVE CLERICAL ACCOUNT, FOR A TOTAL OF \$30,000;

AND FOR THIS PURPOSE, THAT THE SUM OF \$15,000 TO THE POLICE DEPARTMENT / PROGRAM 04 – PATROL BUREAU/OVERTIME ACCOUNT, THE SUM OF \$9,000 TO THE TOWN CLERK/PROGRAM 04 – ELECTIONS/PART-TIME EMPLOYEE ACCOUNT, AND THE SUM OF \$6,000 TO THE TOWN CLERK/PROGRAM 04 – ELECTIONS/ELECTION EXPENSES ACCOUNT:
