REQUEST OF: NATIONAL GRID

National Grid hereby respectfully requests your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and of the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

**To install and maintain approximately 545 feet more or less of 2 inch gas main in Hickory Rd., Braintree. From the existing 2 inch gas main at Liberty St. northerly to the end of main at house #33 Hickory Rd. All of which to replace and abandon the 2 inch gas main in Hickory Road with the following conditions:**

**BELD:** Hickory Road: BELD has a 13,800 volt underground system on the road. This is a concrete encased duct bank to be identified through the Dig safe process.

**DPW:** This section of Hickory Road is not under the moratorium. The street has not been resurfaced in several years. Hickory Road is scheduled to have a new water main installed this summer and we would recommend that the petition for this section is granted as soon as possible so that both the water main and gas main projects can be coordinated and completed in a timely manner. The petition should be granted under the normal conditions, with emphasis on the requirements that the gas main be laid outside of the proposed new water main trench and that the trench pavement not be left low for any length of time; we also recommend that the following requirement be added to the permit, if it is to be granted:

“Neither National Grid nor any of its contractors is authorized to close any street or to close a direction of travel to facilitate their work without authorization from the Director of the Department of Public Works or the Highway Superintendent. The Chief of Police can also authorize a closure for a police or fire emergency. Construction zone traffic safety issues are to be addressed by using appropriate traffic control signs and devices and the use of police officers for traffic control to safely guide traffic through the work zone. If a closure is authorized by the DPW, it shall not be implemented until signs and police officers (where needed) are properly in place in conformity with the written plan prepared by the contractor’s engineer and approved by the DPW and Police Department.”


