Program G02-Building Maintenance: Lighting; \$2,000 and Building Repairs; \$10,000. Program G03-Equipment Maintenance: Gasoline; \$4,800 and Outside Motor Vehicle Repairs; \$2,500. Program G04-Turf Maintenance: Overtime; \$9,000. Program G05-Golf Pro: Merchandise; \$15,000 and Golf Pro; \$1,450. Program G06-Golf Cart Operations: Golf Cart Leases; \$2,500.
