PETITION OF NATIONAL GRID FOR GAS MAIN LOCATIONS

The National Grid hereby respectfully request your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 175 feet, more or less of 2 inch gas main in Burroughs Road, Braintree.

From the existing 2 inch gas main at Elm Street Northerly to House #10. All of which is to replace and abandon the existing 2 inch gas main in Burroughs Road, Braintree.

Petition #11 025 was unanimously approved by Council with the following conditions:

BELD: Burroughs Rd: BELD has 15kV electric distribution lines and 115kV oil filled transmission lines within the proposed scope of work. National Grid Gas or the contractor representative shall contact the BELD Engineering Department at least (48) hours prior to excavating in close proximity to the 115kV transmission line. BELD will provide onsite safety personnel at no cost to National Grid/Contractor during any excavation or installation that may impact this line.

DPW: Burroughs Road between Elm Street and number 10 Burroughs Road is within the limits of the Safe Routes to School project pending in this area. The timing of that project is not yet known, but it is good that this work is now being done. It is our recommendation that this petition **should be approved with our "standard" repair specifications, and that National Grid be advised to pursue this work expeditiously.**


