

After submitting the requested line item transfer requests yesterday, we were made aware of another request from the Council on Aging, who needs funds to be transferred to address a shortfall for outside motor vehicle repairs and gasoline. The source of funds is from surplus amounts within the FY10 Council on Aging budget.

Accordingly, your review and approval of the following motion is requested:

MOTION: THAT THE SUM OF \$500 BE TRANSFERRED FROM THE COUNCIL ON AGING/PROGRAM 03 – BUILDING MAINTENANCE/ BUILDING REPAIRS ACCOUNT AND THE SUM OF \$2,000 BE TRANSFERRED FROM THE COUNCIL ON AGING/PROGRAM 03 – BUILDING MAINTENANCE/FUEL OIL ACCOUNT FOR THE PURPOSE OF TRANSFERRING \$2,500 TO THE COUNCIL ON AGING/PROGRAM 02 – EQUIPMENT MAINTENANCE/OUTSIDE MOTOR VEHICLE ACCOUNT.

Since this request involves the re-appropriation of funds within the fiscal year 2010 budget, advertising and a public hearing is required under Sections 2-9 and 6-7 of the Town Charter.
